The North Carolina Parks and Recreation Trust Fund (PARTF) was established in July 1994 to provide a dedicated funding source for improvements in state parks, matching grants for local parks, and public access to the state's beaches and estuaries. PARTF is funded by annual appropriations as well as revenue from personalized license plates and is administered by the N.C. Division of Parks and Recreation (Division). Per N.C. General Statute § 143B-135.56, PARTF is as follows:

- 65% for the state parks system or a state recreational forest for capital projects, repairs, and renovations of facilities and to acquire land.
 - By resolution of the Parks and Recreation Authority, 4% of this allocation is distributed to the DuPont State Recreational Forest annually.
- 30% to provide grants to local governments on a dollar-for-dollar basis to establish or improve parks and recreational projects.
- 5% for the N.C. Division of Coastal Management's (DCM) Public Beach and Coastal Waterfront Access Program. DCM administers these funds and offers matching grants to local governments in 20 coastal counties.
- The Division of Parks and Recreation may use 3% of their percentage for the operating expenses associated with managing capital improvements projects, acquiring land, and administering the grants program for local governments.

The nine-member NC Parks and Recreation Authority oversees PARTF. The Governor appoints five members, including the chair. The General Assembly appoints four members, two by the President Pro Tempore of the Senate and two by the Speaker of the House. Members are appointed for 3-year terms.

The Authority is charged with six powers and duties:

- to allocate funds for land acquisition,
- to allocate funds for capital projects,
- to solicit financial and material support,
- to receive public and private donations and funds for deposit into the Trust Fund,
- to develop effective support for parks and recreation,
- and to advise the Secretary of the Department of Natural and Cultural Resources (DNCR) on any matter referred to the body.

The Parks and Recreation Authority held four meetings during fiscal year 2024-25.



3.0 Parks and Recreation Trust Fund Revenue Summary

Total PARTF revenue available for state and local parks as well as coastal access projects was \$29,808,124 from appropriations and personalized license plate fees. The state park system received \$18,794,022 (65%), Dupont Forest received \$751,761 (4%) of the state parks percentage. Local governments received \$8,674,164 (30%) in grants to establish or renovate park facilities, and the DCM Coastal Access grant program received \$1,490,406 (5%). Administrative expenses accounted for \$849,532 (3%) (Table 3-1).

4.1 Program Description

Parks and Recreation Trust Fund (PARTF)

The PARTF program provides dollar-for-dollar matching grants to local governments to acquire land for public parks and to build or renovate recreational facilities. N.C. counties and incorporated municipalities are eligible for PARTF grants. Public authorities, as defined by N.C.G.S. §159-7, are also eligible if they are authorized to acquire parkland or develop facilities for public recreation.

Each year, the Parks and Recreation Authority announces the availability of PARTF matching grants and the schedule for applying to local government officials. A local government can request a maximum grant amount of \$500,000 in PARTF assistance with each grant application.

The Division supports local governments in several ways. The Grants and Outreach Program staff post a PARTF application guide online where local governments can learn about the program and how to complete an application. The Department of Natural and Cultural Resources contracts with North Carolina State University to provide technical assistance to local governments through Recreation Resources Service (RRS). RRS provides advice to local governments on preparing grant applications with five consultants in regional offices. An online webinar is hosted when the funding cycle opens.

The members of the Parks and Recreation Authority vote to select grant recipients. The factors considered by the Authority include but are not limited to: the criteria contained in the PARTF scoring system, the population of the applicant community, the geographic distribution of projects across the state, the grant funds requested in comparison to the funds available, and compliance with prior grant agreements. Applications were due on May 1, 2024. The Parks and Recreation Authority met on August 23, 2024 to award the matching grants (Table 4-1, page 7).

Accessible Parks (AP)

Session Law 2023-134, House Bill 259, Section 14.4 (a, b, c)

“Of the funds appropriated in this act from the interest earned in the State Fiscal Recovery Reserve to the Department of Natural and Cultural Resources, the sum of twelve million five hundred thousand dollars (\$12,500,000) is allocated to the Parks and Recreation Trust Fund to provide matching grants to local parks facilities for persons with disabilities and shall be used exclusively for grants to local government units or public authorities, as defined in G.S. 159-7, for construction of special facilities or adaptation of existing facilities that meet the unique needs of persons with disabilities or that enable them to participate in recreational and sporting activities, regardless of their abilities.”

AP provides matching funds in the amount of \$1 of local funds for every \$5 of state funds. A local government can request a maximum grant amount of \$500,000 in AP assistance with each grant application.

The members of the Parks and Recreation Authority voted to select grant recipients. The factors considered by the Authority included but not limited to: the criteria contained in the AP scoring system, the population of the applicant community, the geographic distribution of projects across the state, the grant funds requested in comparison to the funds available, and compliance with prior grant agreements.

There were two application rounds for the AP funding. The first round followed the same schedule as PARTF, with applications due on May 1, 2024, and matching awards made at the August 23, 2024 Authority meeting. The second round opened on September 3, 2024, with applications due on March 3, 2025. The Authority awarded the matching grants at the June 6, 2025 meeting to exhaust the funding (Table 4-2, page 8).

4.2 Applications and Grant Awards

The PARTF revenue available to local grants for fiscal year 2024-25 was \$9,566,875, which includes returned and withdrawn grant funds. Forty local governments submitted PARTF applications, requesting \$15,163,857 in PARTF assistance. The Authority awarded 23 grants totaling \$9,566,875 with an overall impact of approximately \$40.7 million (Table 4-1).

The AP revenue available to local grants was \$12,125,000. Fifty-two local governments submitted AP applications, requesting \$20,265,327 in AP funds. The Authority awarded 32 grants totaling \$12,121,732 with an overall impact of approximately \$16.5 million.

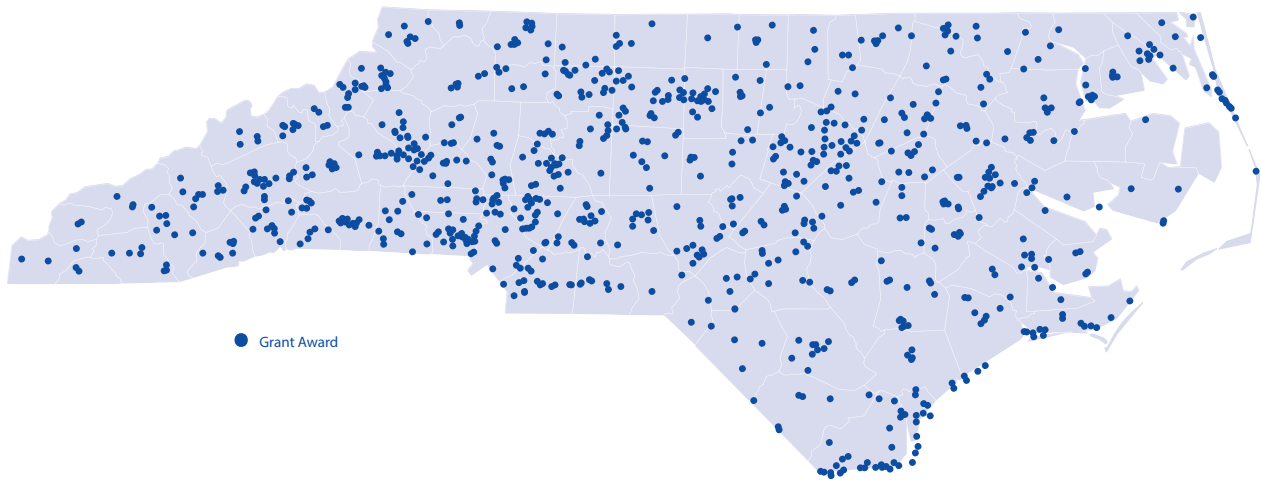

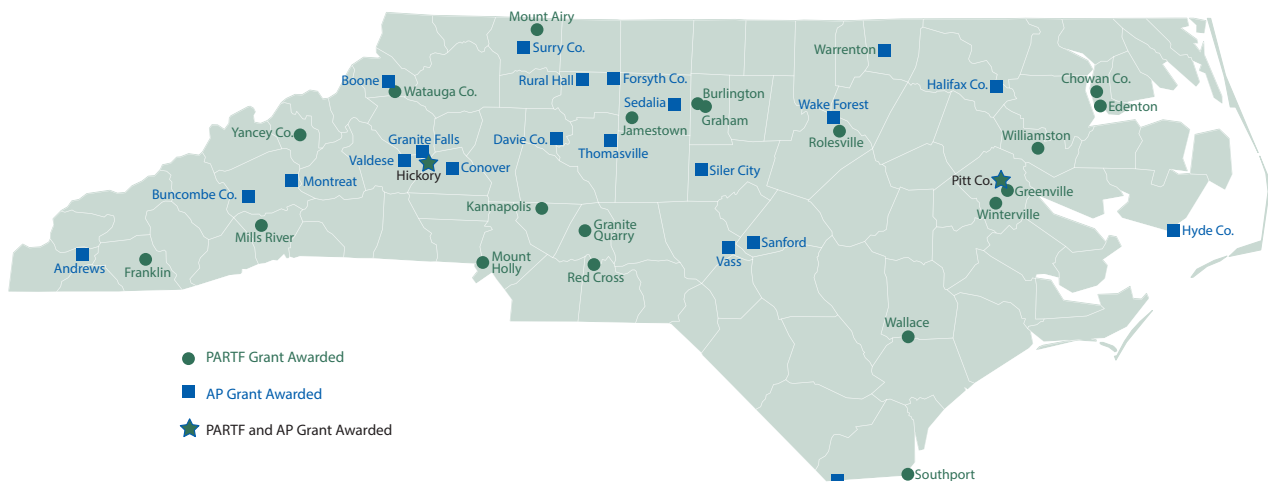
4.4 Geographic Distribution of Grants

Since 1995, the Parks and Recreation Authority has awarded 1,076 matching grants in all 100 counties across North Carolina.

5.0 State Parks Program

The Parks and Recreation Authority allocates PARTF revenue to capital improvement, maintenance and land acquisition projects for the state parks system. The Division develops priorities for the state parks system and recommends projects for the Authority's approval. The PARTF revenue for state park projects for fiscal year 2024-25 was \$18,794,022.

The total amount awarded to state park projects in fiscal year 2024-25 was \$17,742,611, which includes funds from projects from previous years completed under budget or postponed (Tables 5-1 and 5-2, page 14).

The Parks and Recreation Authority allocated \$751,761 for projects at Dupont State Recreational Forest (N.C.G.S. §143B-135.56 (b)(1)). Section 7.0 provides additional information about these projects.

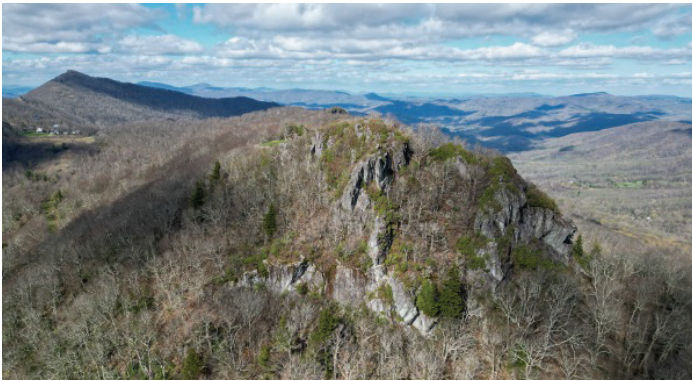
5.3 Operating Expenses Associated with State Park Projects

In allocating PARTF funds to the state parks system, the Parks and Recreation Authority considered the operating expenses that may be associated with the projects (N.C.G.S. §143B-135.56 (e)). The Division estimated these costs and presented them for the board’s consideration when the projects were proposed for funding. The estimated costs are based on conceptual plans for each project and are not funds allocated from PARTF.

The reallocated funding would be used for the following projects:

- **New River State Park:** Campground and river access repairs
- **Mount Jefferson State Natural Area:** Repairs to roads and overlook
- **Grandfather Mountain State Park:** Profile Trail repairs
- **South Mountain State Park:** Trail tread, bridge, and fishing pier repairs
- **Chimney Rock State Park:** Access Road repairs
- **Lake James State Park:** Mountain bike trail repairs, dock replacement, and paddle-in campsite repairs
- **Mount Mitchell State Park:** Restaurant roof repairs
- **Elk Knob State Park:** Bridge repairs to restore back country management access
- **Multiple parks:** Debris removal

6.0 Public Beach and Coastal Waterfront Program

6.1 Program Description

North Carolina's Public Beach and Coastal Waterfront Access Program was established by the General Assembly in 1981. The program began receiving 5% of the revenues from PARTF during fiscal year 1996-97. The program's enabling legislation (N.C.G.S. § 113A-134.1) states that public interest would be served by providing increased access to coastal waters, public parking facilities, or other related public uses.

The program, administered by the Division of Coastal Management (DCM), offers matching grant funds primarily to local governments throughout the 20 coastal counties. Since 1981, over 497 public access sites have been acquired or improved at a cost of over \$53.8 million in grant funds. Local governments are responsible for construction, operation, and long-term maintenance of the facilities. While most of the early projects were located along the oceanfront, more projects are now designed to improve access to estuarine shorelines, coastal rivers, and urban waterfronts.

DCM sends pre-application requests for proposals (RFPs) to local governments in the 20 coastal counties annually. Criteria developed by the Coastal Resources Commission are used to select grant recipients. Local governments are given 18 months to complete projects. Extensions may be granted for unforeseen events and delays, such as hurricanes, with a 3-year maximum life of a contract.

Local governments are required to match from 10-25% of the project costs based on the type of project being funded and the community's economic status per the North Carolina Department of Commerce's Tier designations, as outlined by N.C.G.S. § 143B-437.08. The required cash match may include federal and other state funds, provided these funds are not already being used as match funds for any other state or federal program.

6.2 Types of Projects Funded

Communities can apply for the following types of projects:

Land Acquisition/Easement

- Purchase of land for future public access facilities
- Purchase of easements for public access

Construction Projects

- Facilities such as dune crossovers, boardwalks, and piers that provide access to the water
- Support facilities such as parking areas, restrooms, and other facilities
- Boat launch facilities: boat launch and ramp facilities, whether motorized or not, provided that pedestrian access is still a major component of the project

Rehabilitation

- Urban waterfront access sites: Improved public access to deteriorating or underutilized urban waterfronts through reconstruction or rehabilitation
- Reconstruction or relocation of existing damaged public access facilities: Primarily for sites not originally funded by this program or for improvements to any sites at least 15 years old

6.3 Awards for Fiscal Year 2024-25

State appropriations are allocated to DCM through PARTF. The amount transferred from the PARTF to DCM during fiscal year 2024-25 was \$1,490,406. The amount budgeted for grants in addition to this allocation includes an added \$1,363,848 of funds unused from previous fiscal years and returned funds from previous grants. The above project list does not include any direct partnerships with other state agencies. The only non-award use of the funds is providing access site signs made by the Department of Adult Correction. Signs are provided to local governments for new sites and for replacement of weathered signs.

DuPont State Recreational Forest

Since 2017, in keeping with N.C.G.S. § 143B-135.56, the Parks and Recreation Authority allocated 4% of the annual appropriation for state parks for capital projects, repairs, renovations, and land acquisitions at DuPont State Recreational Forest (DSRF). The amount transferred was \$751,761. In fiscal year 2024-25, state forest staff made progress on capital projects supported by PARTF funds, expending a total of \$394,408. Table 7-1 provides a summary of expenditures.
